Continuing Students – Eligibility to Enrol

This section is for all students who are continuing with their studies from one academic session to the next.

Progression Decisions

Progression decisions are made at a Progression and Award Board (PAB). The table below contains guidance on what to do next and when online enrolment will become available, depending on the decision you received at the PAB.

Decision	Do I need to do anything else?	When can I enrol online?
Proceed Select	Enrol for the next year of your programme.	From 9 August 2017
Proceed Next	Enrol for the next year of your programme.	From 9 August 2017
Proceed Current	Enrol for the next year of your programme.	From 9 August 2017
Proceed Deficit	You need to obtain guidance on resitting the module(s) you have failed, and having them added to the next year of your programme.	From 9 August 2017
Proceed Transfer	You need to contact your Personal Tutor for guidance to select the programme you are transferring to.	From 9 August 2017 (if the transfer form has been completed)
Defer Resit (June decision)	You need to have taken some re-assessments over the summer before you can enrol.	Once the August PAB has met and informed you of their decision. You will find your module results and PAB decision on Self Service Banner
Defer Resit (August decision)	Enrol as an Assessment Only student. This means that you would not normally be in full attendance. You should seek guidance from your Personal Tutor. The fee for registering as an Assessment Only student is £40.00.	From 4 September 2017
Ongoing Enrol		You will be able to enrol once your 'ongoing' modules have been added by your School.
Fail Repeat	You need to obtain guidance about options available to you e.g. programme, modules, etc., and you are advised to seek funding advice.	You will not be able to enrol until you have contacted your programme leader or Student Administration for advice and information on how to proceed.
Defer Chair	The PAB has still to make a decision.	You will not be able to enrol until you receive a decision from the PAB that allows you to enrol.
Fail Withdraw	You have been withdrawn from your programme of study.	N/A

Additional Information for Nursing and Midwifery Students

In addition to the decisions listed above, students in the School of Health Nursing and Midwifery may receive a decision of Proceed. This means that you can progress to the next stage of your programme but are carrying modules that you are still required to pass. The implications for enrolment are dependent on when you receive this decision.
