Self-financing Non-EU students are required to pay £3500 for their CAS. The remaining balance of tuition fees will be eligible for a 10% early payment discount if paid 7 days prior to classes commencing. Otherwise payments can be made below.

Payment plans for International Students

September Intake:

- 1st Instalment: September prior to enrolment
- 2nd Instalment: 1 November
- 3rd Instalment: 1 February

January Intake:

- 1st Instalment: January prior to enrolment
- 2nd Instalment: 1 April
- 3rd Instalment: 1 July
