

If you make a successful immigration application, you will be issued with one of the following documents: a vignette for full length of permission; or a 90-day vignette; or a biometric residence permit

BIOMETRIC RESIDENCE PERMITS (BRP) COLLECTION

DO I NEED TO COLLECT MY BRP?

Yes. Normally if you are granted a short stay permit to come to the UK, you need to collect your BRP from a specified Post Office within 10 days of arrival.

WHEN CAN I COLLECT MY BRP?

Your decision letter will tell you the date from which your BRP will be available for collection. You may go on or after this date.

WHAT DO I NEED TO TAKE TO COLLECT MY BRP?

You must bring with you

- 1. The passport or travel document which contains your 30 or 90 day visa.
- 2. Your decision letter.

WHERE DO I COLLECT MY BRP?

Visit the <u>Post Office website</u>. Click on the red 'Branch Finder' link at the top right of the screen. Enter the postcode or street name of the Post Office address stated on your home office BRP collection letter then click the red 'Choose a service' link and choose 'Home Office Biometric Enrolment' and hit the red 'Search' button. You will then be directed to the branch opening hours and a map of where it is located. You can use <u>Google Maps</u> to get directions to the Post Office.

WHAT DO I DO AFTER I HAVE COLLECTED MY BRP?

You must check your BRP carefully when you receive it, to make sure that all the details on it are correct. If you find a mistake, you must report it online within 10 working days of receiving your BRP. Once you have collected your BRP, Scottish campus students please send a scanned copy of the front and back of your BRP to the hub at hub@uws.ac.uk and for London students please send to London.ukvi@uws.ac.uk or take to an in person check point on campus.

WHAT DO I DO IF THERE IS A CHANGE IN MY CIRCUMSTANCES?

You must inform the Home Office immediately if any of your personal details have changed (for example your address). Changes must be reported online. Report a change of circumstances if you have a visa or BRP: You're in the UK and have a BRP - GOV.UK (www.gov.uk)

WHAT TO DO IF MY BRP IS LOST/STOLEN OR DAMAGED?

You can report you have lost your BRP and apply for a replacement on GOV.UK website

Please note that the instructions you need to follow are different depending on whether your documents are lost/stolen inside or outside the UK. If you lose your BRP, please take action as soon as possible, as you may be fined if you do not apply to replace your BRP within 1 month.

DIGITAL STATUS

EU and EEA nationals who have used the UK Immigration: ID check app receive their visa in the form of an online digital status.

As well as your online digital status you should also receive an accompanying letter from the Home Office confirming the grant of your immigration permission. This letter contains instructions on what you need to do if you spot any errors (in your personal details) with your online digital status.
