Research and Innovation Policy Statement

Aim

This Policy Statement sets out our approach to foster a culture of research excellence, impact and collaboration driving transformative research and innovation to address global challenges and fuel economic growth locally, nationally and globally. The University is committed to maintaining the highest ethical standards in research and scholarship and supporting a positive environment where researchers can innovate, grow professionally and deliver impactful solutions for the benefit of business society and the economy. This Policy Statement sets out the broad principles by which the University operates and should be read along with the related guidelines, procedures and protocols referred to below.

Scope

This Policy Statement and all referenced guidelines, procedures and protocols apply to all staff and students of the University unless otherwise indicated within the scope of the individual policy related document.

Principles

The University is fully committed to ensuring that our research governance arrangements:

- commit to the highest standards of rigour, integrity and ethics in all aspects of research
- provide for proper accountability.
- are open, inclusive and transparent.
- meet all relevant legal requirements and obligations.
- promote collaboration and partnership and policy influence
- support researcher development and well-being
- drive innovation and impact
- promote knowledge transfer, commercialisation and public engagement
- align with environmental and sustainability goals.

As part of our commitment, we:

- support a research environment that promotes good practice and is underpinned by fair and transparent processes to deal with allegations of misconduct in research when they arise
- enable and support best practice in research data management at UWS, reflecting the University's commitment to the UK Concordat on Open Research Data.
- provide support and guidance to help individuals to identify when export controls and sanctions might apply, setting out the procedure to be followed to ensure compliance with export control and sanctions legislation;

- provide clear guidelines and standards to support Doctoral Student progression and well-being.
- will provide guidance and advice to staff in order to encourage the early identification of intellectual property and allow successful exploitation for the mutual and equitable benefit of all contributing parties.
- will ensure it has appropriate procedures in place for the management of consultancy activities and service work provided by the University's staff under the auspices of the university.

Responsibilities

The endorsement and upholding of the principles of this Policy Statement are the responsibility of the Senate. The Pro-Vice-Chancellor (Research & Innovation) is responsible for leading the activities within the University, which fall under this Policy Statement.

Approval

This Policy Statement was approved by the Research and Innovation Committee on 5th November 2024.

Monitoring and Review

This Policy Statement will be reviewed as needed due to changes in legislation, standards or sector good practice or where a reorganisation changes ownership, responsibility or accountability. All related Guidelines, Procedures and Protocols will be reviewed annually in line with the University's Annual Compliance Monitoring Statement.
